## Orpheus Minerals Ltd IPO – Extension of General Offer and Priority Offer Closing Date to 2 December 2022

Argonaut Resources NL (*Argonaut*) (ASX:ARE) refers to the initial public offering of fully paid ordinary shares currently being undertaken by Orpheus Minerals Ltd (*Orpheus IPO or Offer*) pursuant to a prospectus dated 17 October 2022 (*Orpheus Prospectus*). Capitalised terms that are used but not defined in this announcement have the meanings given to them in the Orpheus Prospectus.

Argonaut advises that the Argonaut Priority Offer Closing Date and General Offer Closing Date has been extended from Friday, 25 November 2022 to Friday, 2 December 2022.

This will provide Eligible Argonaut Shareholders with a better opportunity to participate in the Argonaut Priority Offer component of the Orpheus IPO.
